In keeping with Florida Statute, the Leon County Supervisor of Elections Office will utilize the Clear Ballot audit system to conduct post-election audits. As specifically addressed in statute and rule, Leon County Elections staff will scan ballots into this system periodically throughout the election in advance of conducting post-election audits or the calling of any recounts. All scanning into the recount/audit tabulation system will take place during publicly noticed and accessible sessions. If you want to have a formal observer present during this process, then you or an observer you designate must be present at the times listed in the canvassing board activity calendar.
