Check your voter status anytime at LeonVotes.org! Click *Your Voter Info*.

After registering, you must keep your registration information up to date. Your current name, address, and signature are critical for your vote to count. To update your voter information, choose from the following options:

Signature Change / Update (**VERY IMPORTANT**)

We use voter signatures to verify your identity on Petitions, Provisional Ballots, and Vote-by-Mail ballots. For your vote to count, we need an up-to-date signature on file. Update your signature by completing a Voter Registration form and sending it to us. Forms are available on our website at Leonavotes.org.

Address Change *(no deadline)*

- Go to LeonVotes.org/OVR or LeonVotes.org/update.
- Call our office.
- Submit a completed Florida Voter Registration Application.
- Submit a signed written notice that includes your name and date of birth or voter registration number.

Party Affiliation Change *(deadline is 29 days before a primary election)*

- Submit a completed Florida Voter Registration Application or a signed written notice that includes your name and date of birth or voter registration number.

Name Change *(no deadline)*

- Submit a completed Florida Voter Registration Application or a signed written notice that includes your name and date of birth or voter registration number.

Rights and Responsibilities

VOTER'S BILL OF RIGHTS

Each registered voter in this state has the right to:

1. Vote and have her or his vote accurately counted.
2. Cast a vote if he or she is in line at the official closing of the polls in that county.
3. Ask for and receive assistance in voting.
4. Receive up to two replacement ballots if he or she makes a mistake prior to the ballot being cast.
5. An explanation if his or her registration or identity is in question.
6. If his or her registration or identity is in question, cast a provisional ballot.
7. Written instructions to use when voting, and, upon request, oral instructions in voting from elections officers.
8. Vote free from coercion or intimidation by elections officers or any other person.
9. Vote on a voting system that is in working condition and that will allow votes to be accurately cast.

You may have other voting rights under state and federal laws. If you believe your voting rights have been violated, please contact the Florida Department of State's Voter Fraud Hotline at (877) 868-3737.

VOTER'S RESPONSIBILITIES

Each registered voter in this state should:

1. Familiarize himself or herself with the candidates and issues.
2. Maintain a current address with the Supervisor of Elections.
3. Know the location of her or his polling place and its hours of operation.
4. Bring proper identification to the polling station.
5. Familiarize himself or herself with the operation of the voting equipment in his or her precinct.
6. Treat precinct workers with courtesy.
7. Respect the privacy of other voters.
8. Report any problems or violations of election laws to the Supervisor of Elections.
9. Ask questions, if needed.
10. Make sure that his or her completed ballot is correct before leaving the polling station.

NOTE TO VOTER: Failure to perform any of these responsibilities does not prohibit a voter from voting.



Who Can Register to Vote?

Am I eligible to register to vote in Leon County, Florida?

You must:

- Be a U.S. Citizen
- Be a Florida resident and live in Leon County
- Be 18 years old (*you may pre-register at 16 or 17*)
- Not currently be adjudicated mentally incapacitated with respect to voting in Florida or any other state
- Not have been convicted of a felony, or if you have a felony conviction, you must have had your right to vote restored

Voting Rights Restoration

Starting January 8, 2019, convicted felons that have completed their sentences, including parole and probation, will have their voting rights automatically restored and will be eligible to register to vote.

EXCEPTION: Felons convicted of murder or sexual offenses are not eligible unless the Florida Commission on Offender Review, Office of Executive Clemency restores their voting rights.

How do I know if my voting rights have been restored?

The voting rights for most convicted felons in Florida are automatically restored when all terms of your sentencing are completed.

3 Ways to Register

Registration applications for new voters must be completed and submitted 29 days before an election to be effective for the upcoming election. Go to LeonVotes.org (click *Register to Vote*) for more info on how to register to vote. Or, contact our office.

1 Try Online Voter Registration!

You can register to vote or update your existing registration online at LeonVotes.org/OVR. Online Voter Registration (OVR) requires a Florida driver's license or Florida identification card and the last four digits of your Social Security number.



2 Register In Person

Register to vote in person at the Leon County Supervisor of Elections office, at a voter registration agency, or at a community outreach event.

1 Vote-by-Mail

Contact our office online, in person, by phone, or by mail to request your Vote-by-Mail ballot before Election Day.



2 Vote Early

Cast your ballot at any of our convenient locations before Election Day. Go to [LeonVotes.org](https://www.leonvotes.org) to see a list of Early Voting sites in Leon County.



3 Vote at Your Precinct

It's your last chance to vote! If you choose to vote on Election Day, you must cast your ballot at your assigned polling place. To find your polling place, call us or go to [LeonVotes.org](https://www.leonvotes.org) (click *Your Voter Info*).

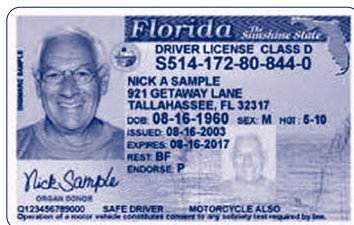




Voting In Person

Voting in person in Florida requires a valid ID containing your photo and signature. The photo and signature may come from a combination of IDs from the following list:

- Florida Driver's License or Florida Identification Card as issued by the Department of Highway Safety and Motor Vehicles



- US Passport

- Debit or Credit Card

- Military ID

- Student ID

- Retirement Center ID

- Neighborhood Association ID

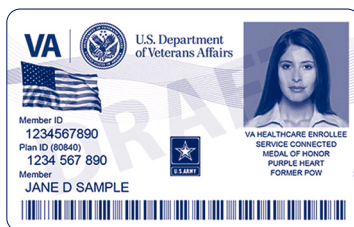
- Public Assistance ID

- Veteran Health ID issued by the United States Department of Veterans Affairs



- Concealed Weapon / Firearm License issued pursuant to 790.06, F.S.

- Employee ID issued by any branch, department, agency, or entity of the Federal Government, the State, a county, or a municipality



Your Voter Information Card does not count as valid ID to vote. If you are not able to produce proper ID, you can still vote using a Provisional Ballot.

You may request your Vote-by-Mail ballot up to 10 days before an election. You may return your voted mail ballot to our office or drop it off with an election official at any Early Voting site during voting hours. **NOTE:** Mail ballots are not accepted at the polls on Election Day.

To ensure your vote is counted,

- Make sure we have an up to date signature for you.
- The Leon County Supervisor of Elections office must receive your ballot by 7:00 pm on Election Day.
- Carefully follow all instructions on your mail ballot.
- Sign the Voter's Certificate on the envelope with a good signature.
- Allow up to 5 business days if returning by mail.

Election Day Voting

Election Day is your last chance to vote!

If you choose to vote on Election Day, you must cast a ballot at your assigned polling location. Your **polling location** is a building that serves voters of one or more precincts. It is based on your **precinct**, which is a geographical area defined by overlapping governmental districts.

Your polling location and precinct number are listed on your Voter Information Card for your reference. Voter Information cards are mailed routinely to confirm new registrations, voter updates, or changes in precincts or polling locations.

Note: Your Voter Information Card does not count as valid ID to vote.

Avoid The Rush

Polls are open from 7:00 AM to 7:00 PM. The busiest voting times happen right at the opening and closing of the polls. We suggest you vote between 10:00 AM – 4:00 PM to avoid long lines.

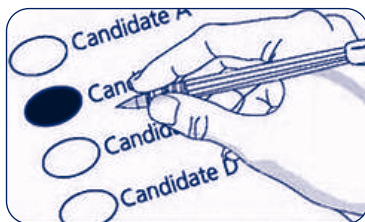


What to Expect at the Polls

Voting should be a quick, satisfying experience. Ask a poll worker for assistance if needed.

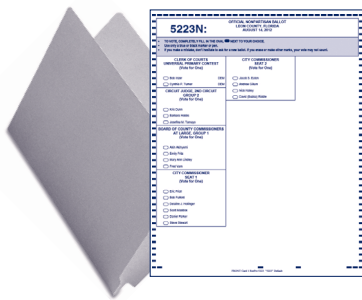
Voters must present valid ID with a photo and signature. After verification, voters must sign the precinct register (an electronic pollbook). Then, voters receive a paper ballot and a privacy folder.

Voters may bring their marked sample ballots or other materials for reference when marking their official ballot at the polls.



1. Fill in your ballot correctly.

Completely fill in the oval to the left of the candidate or issue of your choice. For a write-in candidate, fill in the oval to the left and write the name on the line provided.



2. Review your ballot. If you wish to change anything, ask a poll worker for a new ballot. You are allowed up to 3 attempts to properly mark your ballot.

3. Cast your ballot. Place your ballot into the voting machine, wait for the machine to accept your ballot, and then return the privacy folder to the poll worker. Exit the voting area.



Voting Machines



- Voters can only cast one ballot in any election.
 - Voters are allowed up to 3 attempts to properly mark their ballot.
 - When voting in person, use the marker provided in the privacy booth.
 - Before you cast your ballot, be sure your ballot reflects your choices.
- Once your ballot is cast, you cannot receive another ballot in that election.

All precincts are equipped with optical scan voting machines, which count paper ballots with ovals filled in by the voter. All of our optical scan voting machines feature an ADA compliant voting device to allow voters with disabilities to vote independently using:

- Enlarged font
- Audio ballot
- Controller (*input buttons in Braille*)
- Sip-and-puff
- Two-switch device

The ADA compliant voting device is made available upon request.



Provisional Ballots

A Provisional Ballot is a voter protection tool for a voter whose eligibility to vote is uncertain. It allows the Supervisor of Elections office to count the voter's ballot after the office determines that the voter is eligible. **Voters may track their Provisional Ballot status at [LeonVotes.org](https://www.leonvotes.org) or by contacting our office.**

Some Provisional Ballot voters may be required to submit additional eligibility documentation by the second day following the election to the Supervisor of Elections office for their ballot to be counted.

The Leon County Canvassing Board decides if the Provisional Ballot will be counted when it meets on the third day following the election.

Provisional Ballots are often *issued* when:

- The voter does not show proper ID when voting in person.
- The voter's name is not found in the precinct register (electronic pollbook).

Provisional Ballots are often *not counted* when:

- The voter arrives to vote in the wrong polling location on Election Day.
- The voter did not register 29 days before the election.

Florida's Closed Primary Elections

You are not required to register with a political party. However, Florida is a closed primary state. That means you may only vote in a partisan contest in a Primary Election if you are a registered member of that political party.

Political party affiliation changes must be submitted 29 days prior to the Primary Election.

In a Primary Election, often there are many non-partisan offices up for election. Regardless of political party affiliation, voters may vote in these contests when they appear on the ballot.

When does a Universal Primary contest occur?

A Universal Primary contest occurs when two candidates of the same political party affiliation appear on the Primary Election ballot and face no opposition in the General Election. In a Universal Primary contest, all eligible voters, regardless of political party affiliation, may participate.

In a General Election, voters may select the candidate of their choice regardless of political party affiliation.



Registering With Special Circumstances

Voting Rights Restoration

If you are a former convicted felon and you have completed all terms of your sentence, you are eligible to register to vote under s. 4, Art. VI of the State Constitution. To register to vote, visit [LeonVotes.org/OVR](https://www.leonvotes.org/OVR). Complete and submit a Florida Voter Registration Application (*online or download paper form*).

Pre-register to Vote

If you are 16 or 17 years old, you may pre-register to vote. Complete and submit a Florida Voter Registration Application (*online or download paper form*). Then, you may vote in any election occurring on or after your 18th birthday.

Homeless Residing in Leon County

If you are homeless you may register to vote using a shelter address as your residence, and if you have a place where you receive your mail, that address should be used as your mailing address.

U.S. Military / U.S. Citizens Overseas

If you are U.S. military or a U.S. citizen residing overseas, you may find detailed information about voter registration and voting at www.FVAP.gov or [LeonVotes.org](https://www.leonvotes.org) (click *Vote-by-Mail*).

College Students Residing in Leon County

If you reside in Leon County for school, you are eligible to register to vote here. This may be the most convenient option considering that many voting precincts and early voting sites are located on or near our local campuses.

If you choose to register or keep your registration active in your home county, contact your home county's Supervisor of Elections for more information about the Vote-by-Mail process and request options.

Request a Speaker – The Supervisor of Elections or staff from the Elections Office will speak to your class, club, organization, or group about the election process and voting.

Invite The Elections Office To Your Event – A representative from the Supervisor of Elections Office will set up a non-partisan voter registration table at your event as scheduling permits.

Student Government Elections – The Elections Office offers one no-cost election per year to any school in Leon County as a means of voter education. Participating schools and students may vote for school offices using official ballots and voting machines.

Voter Registration / Education Program – Election staff provides voter registration and education services to area high schools, Tallahassee Community College, Florida State University and Florida A&M University.



Become a Poll Worker

We need poll workers! Each election year, we recruit a diverse pool of public servants of all skill levels to carry out official election duties at the polls. We are ready to teach you everything you need to know to do the job. The job is easy and anyone who has worked at the polls will tell you it is one of the most rewarding ways to help your community.

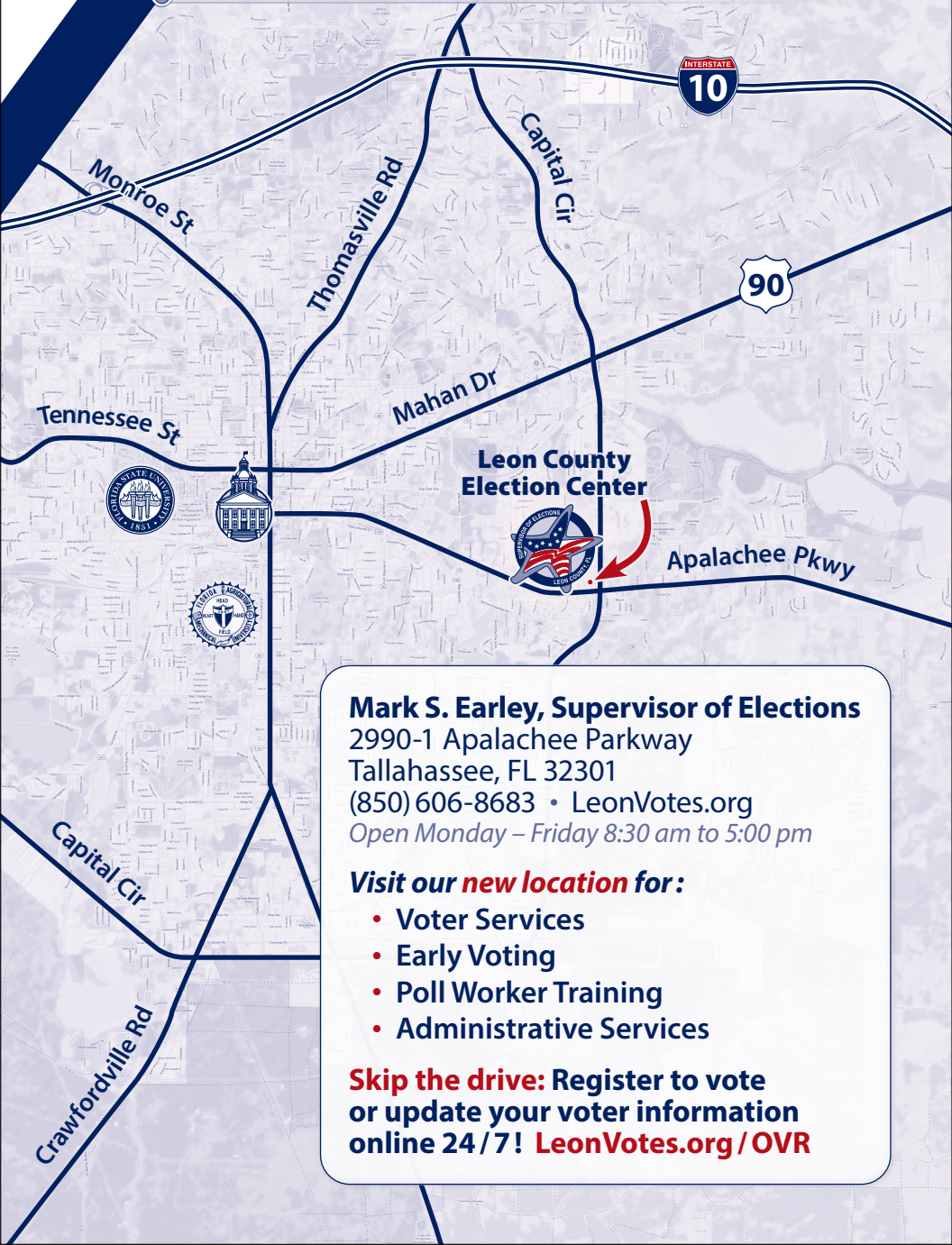
