What Is the Presidential Preference Primary Election?

The Presidential Preference Primary (PPP) is part of how we select presidential candidates.

In the PPP, voters registered with Florida's major political parties vote for the presidential nominee they want to represent their party in the November General Election.

After the PPP, political party delegates nominate the preferred presidential candidates at each party's national convention. These national conventions are typically held in July or August. The party decides at the convention which presidential candidate will represent their party on the November General Election ballot.

Who Is on my PPP Ballot?

There is only one contest on the PPP ballot - which presidential nominee you want to represent your party in the November General Election. The choices that appear on the PPP ballot are designated by the Florida Democratic Party and the Republican Party of Florida. Since the Florida Democratic Party nominated Joseph R. Biden, Jr. as their sole presidential nominee, only voters registered with the Republican Party of Florida will have a ballot in the Presidential Preference Primary Election. Voters registered with the Democratic Party, a minor party, or no party will not receive a ballot in this election.

Voter Registration in the PPP

If you were registered to vote in Florida with the Republican Party of Florida by the February 20 voter registration deadline, you are eligible to vote in the PPP. February 20 was also the deadline to change your party affiliation in time for the PPP.

You can verify your voter information using any of these options:

- Visit **LeonVotes.gov**, click on the *Your Voter Info* button and enter your information. Here you can view your voter info, see your sample ballot, locate your Election Day polling place, check Early Voting schedules and locations, and even request a Vote-by-Mail ballot!
- Check your Voter Information Card. Your polling place and party affiliation are listed on the card, along with other important information.
- Call our office and we will be happy to confirm your information. You can call us at (850) 606-8683.

Early Voting

Early Voting makes voting in person easy and convenient. Sites are open from Saturday, March 9 – Sunday, March 17, with hours varying by location. You can vote at any of the 10 sites throughout Leon County.

Election Day is your last chance to vote! Voting hours are 7 a.m. to 7 p.m. on Tuesday, March 19. You must vote at your assigned polling place. All voters waiting in line at 7 p.m. will have the opportunity to vote.





HOW TO REQUEST A BALLOT

Online: Visit LeonVotes.gov and click "Vote-by-Mail".

By phone: Call (850) 606-8683

In person: Visit our office at 2990-1 Apalachee Parkway to pick up your ballot in person. You can also designate someone to pick up a ballot for you.

The deadline for us to receive your request for a mailed ballot is 5 p.m. on Thursday, March 7.

If you miss this deadline, you can still pick up a Vote-by-Mail ballot in person through Election

Day. However, beginning on March 9 if you want to pick it up you must complete a form declaring why you cannot vote in person.



You must sign your Vote-By-Mail Ballot Certificate!
No one else can sign for you.

TRACK YOUR BALLOT

You can track the status of your Vote-by-Mail ballot at **LeonVotes.gov**. Click on the "Voter Info" button to view the latest information. You can also sign up to receive automatic notifications about your mail ballot's status. Visit LeonVotes.gov and click on "Vote-by-Mail" to learn more.

RETURNING YOUR BALLOT

Follow the instructions enclosed with your ballot. We must receive your ballot by 7 p.m. on Election Day, March 19, in order to count it. You can return your ballot by mail or drop box. Note that you CANNOT return Vote-by-Mail ballots to Election Day polling places.

Mail: Use one First Class "Forever" stamp to mail your ballot. The Post Office recommends that you mail it at least one week before Election Day.

Drop Box: You may drop off your Vote-by-Mail ballot at any Early Voting site during voting hours in one of our official Secure Ballot Intake Stations (*also known as drop boxes*). See the Early Voting section of this guide for schedules and locations. You can also return it directly to the Elections Office.

SIGNATURE REVIEW: We check the signature on your Vote-by-Mail ballot envelope to confirm you sent it. If your signature is missing or does not match our records, we will contact you to fix the issue. The deadline to fix any signature issues is 5 p.m. on Thursday, March 21.



Tuesday, March 19 is Election Day – your last chance to vote!

If you vote on Election Day, you must cast your ballot at your assigned polling place. Your polling place is based on your precinct (where you live). You can find your polling place on your Voter Information Card. You can also look it up online at LeonVotes.gov. For assistance, please call us at (850) 606-8683.

Your polling place is open 7 a.m. to 7 p.m. on March 19, Election Day. All voters waiting in line at 7 p.m. will have the opportunity to cast a ballot. If you decide to wait until Election Day to vote, please check LeonVotes.gov for any last minute changes that might affect your ability to vote at your normal polling place.





Photo and Signature ID

Voting in person at an Early Voting site or on Election Day requires valid photo and signature ID. The photo and signature can come from a single ID or a combination of IDs from this list:

- Florida Driver's License
- Florida Identification Card
- US Passport
- Debit or Credit Card
- Military ID
- Student ID
- Retirement Center ID
- Neighborhood Association ID
- Public Assistance ID

- Veteran Health ID issued by the United States Department of Veteran Affairs
- Concealed Weapon / Firearm License issued pursuant to \$790.06, F.S.
- Employee ID issued by any branch, department, agency or entity of the Federal Government, the State, a county, or a municipality.







Your Voter Information Card <u>does not count</u> as ID. If you did not bring valid ID to the polls, you can still vote using a Provisional Ballot.

A **Provisional Ballot** is a backup for a voter who forgets their ID or whose eligibility cannot be verified at the polling site. It allows us time to research the voter's eligibility and count the ballot if the voter is eligible.

Some Provisional Ballot voters may need to submit additional information for their ballot to be counted. The deadline to submit this is 5 p.m. on Thursday, March 21.

We are committed to aiding voters with disabilities and ensuring that everyone can exercise their right to vote. If you need assistance when voting, ask the clerk at the voting site and they will be happy to help.

Assistance at the Polls

You can bring a helper with you to vote. They can be in the privacy booth with you to assist you with marking and voting your ballot. You can also request help from election workers.

Voting Equipment

All Early Voting sites and Election Day polling places are accessible and supplied with equipment that helps voters with disabilities cast their ballots. You can use it to mark your ballot in secret with little or no help from other people. For voters with blindness or low vision, the system has an audio feature that will read the ballot to you.

Accessible Voting by Mail

With a Vote-by-Mail ballot, you can vote from the comfort of your home. You can have someone help you mark your ballot, but you must sign the certificate on the envelope. We have an accessible Vote-by-Mail option for voters with disabilities. Contact us to learn more.

submitted only one name for their
party, Joseph R. Biden, Jr, there is
no Democratic Party ballot in this
election.

Your first chance to vote in 2024!

The Presidential Preference Primary is a special kind of election. Nothing else we have in Florida is quite like it. In fact, the names on the ballot are not even technically candidates, as the "winner" is not elected to office. Instead, the PPP allows voters registered with Florida's major political parties to direct their state party's support to a specific nominee at the party's nominating convention. This also explains why there is no Democratic Party ballot in this PPP, as they only nominated a single name.

This system is rather complicated, but necessary due to the unique nature of the office of President. It is the only elected office that crosses state lines. It's as simple, and as complicated, as that. This single fact helps to explain why we have presidential primaries, nominating conventions, and of course the Electoral College. We have a long and winding road ahead of us, one that starts with a ballot in your hands, and ends with someone reciting the oath of office to the most powerful position our world has

ever seen: President of the United States of America.

Running a presidential election is a great responsibility, and my office treats it with the utmost seriousness. Security is our top priority. You can be sure that your vote is counted fairly and accurately, and that our system is secure from tampering. We go above and beyond by auditing every vote on every ballot to ensure that the results are accurate and free of fraud. Regardless of whether you plan to vote early, at your polling place on Election Day, or by mail, you can trust that your vote will count. And if you do plan on voting by mail, make sure that we have your mail ballot request on file, as a recent change in Florida law resets the requests after each election year.

Every election is a moment in history, and as a registered voter you have the awesome power to participate in this process. And it starts here, in Leon County, with a ballot in your hands.

Your vote is your voice. Please speak up, vote, and be heard!
